

## PCoC Certificate | SCoC Certificate – Saudi Arabia

The Kingdom of Saudi Arabia recognizes Applus+ as a Conformity Body for the product certification of Asia and Pacific imports.

The Kingdom of Saudi Arabia requires that all consignments of products that are covered by a Saudi Standards, Metrology and Quality Organization (SASO) Technical Regulation and that are to be exported to the country should be issued with a Product Certificate, and that every consignment should be accompanied by a Shipment Certificate. These certificates signify compliance with the applicable standards and technical regulations.

## What is the PCoC and SCoC

The PCoC is the product conformity certificate that is issued by an approved and accredited conformity assessment body such as Applus+, for all registered products in the SABER platform. Every PCoC issued for each model remain valid for 1 year.

The SCoC is the shipment certificate that is issued upon client request also through the SABER platform on the basis of an official signed stamped commercial invoice, packing list, bill of lading and other shipment-related documents. The SCoC is to be issued prior to shipment arrival and remain valid until all goods in the commercial invoice successfully clear Saudi customs.

With Applus+ SABER CoC service, this process shall be hassle-free for our clients since we primarily focus on safe trade practice and reducing complexity from clients daily operations.

## **CERTIFICATION PROCESS**

The products included in the Technical Regulations by SASO must comply with the rules established in SALEEM/SABER and have completed the designated processes before the products are shipped to Saudi Arabia.

#### Step 1: product information collection

- Determine the tests required by SASO for the specific product by reviewing the product sample and details (technical data sheet, specifications, photos.
- If testing requirement is incomplete: sample collection and sending to an Applus+ laboratory ISO/IEC 17025 accredited.
- Issuance of the corresponding test reports.

#### Step 2: product Certificate of Conformity (PCoC)

- Review of the request received via the SABER portal.
- Distributor's submission of the required documentation to conduct the evaluation.
- Evaluation of the documentation provided by both distributor and laboratories towards the issuance of the PCoC.
- Audit of the factory production system (only applicable to Type 3 products).
- Issuance of the report based on the process results.
- Issuance of the PCoC certification via the SABER portal.

#### Step 3: shipping Certificate of Conformity (SCoC)

- The distributor requests the issuance of the SCoC through the SABER platform.
- The distributor submits the required documentation for the shipment and the technical evaluation provided by the Applus+ expert.
- Issuance of the SCoC through the SABER platform.
- This process must be conducted for each shipment the distributor wishes to send to the Saudi market.
